# **Executive Summary**

NHS Hambleton, Richmondshire and Whitby CCG, NHS Harrogate and Rural District CCG and NHS Scarborough and Ryedale CCG have aligned committees to work more closely together.

The Joint Business Executive Committee has been established to ensure executive and clinical directors have clear oversight and grip on the transformation and efficiency programme in the CCGs.

The Committee ensures financial sustainability whilst improving patient experience and outcomes through transforming care. The Committee monitors programmes and transformation plans that seek long term solutions to financial challenges across care systems. The Committee also receives investment opportunities and business cases, advise committee members on their implications and to approve, in line with the CCGs' operational scheme of delegation. If the investment or business case exceeds the committees approval limit the committee makes recommendations and highlight key factors to the Governing Body to assist them to make a decision.

# Joint Business Executive Committee Key Messages

The Joint Business Executive Committee met on the 29 October 2019 at HaRD CCG Offices. The committee was quorate with representation from all 3 CCGs.

There were 20 attendees with some presenting papers and supporting information. One GP Governing Body member joined by phone. Conflicts of interest were noted and managed as per CCG policy in relation to the business of the meeting.

## **Key items discussed and minuted:**

- Report from the Head of Business Change on North Yorkshire CCGs Financial and Operational Planning.
- Report from the Deputy Director of Finance on Long Term Plan Strategic Financial Planning. This included the initial assessment of in year position and the significant QIPP challenge in 2020/21.
- Joint Business Executive Committee noted the Medicines Management minutes from August 2019 and approved the recommendations from September.
- Report from Head of Strategy (Planned Care and Primary Care) on Transforming out of Hospital Care – Change programme.
- Verbal update from the Director of Acute Commissioning on current issues and themes within Scarborough Acute Services.
- Verbal update from the Director of Acute Commissioning on the HRW Management Activity Plan.
- Report from Head of Strategy and GP Governing Body member on the Primary Care Local Enhanced Service (LES) Review.

### **Decisions made:**

Report from Head of Strategy on the Harewood Sustainability Plan. This included the
current financial issues associated with delivering primary care services, to a unique and
complicated patient population, and propose a way forward to make such practice services
sustainable. The Joint Business Executive Committee proposed to make the practice more
sustainable while the Integrated Care Centre (ICC) is developed over the next 3-5 years and
therefore supported options 3, 4 and 5.
